# THE FAMILY BURIAL GROUND, RIGHT AND RESPONSIBILITIES SUBMITTED BY BETTY BURDAN

In the days prior to public cemeteries and in some cases before burial grounds were established by churches, there was the private family burial ground. Once established they became sacred places, entitled to reverence and respect. Family members and descendents, were not only buried there, but shared in the responsibility of caring for these sacred spaces.

Peter Rothermel, patriarch of the Rothermel clan in Maidencreek and Richmond Townships, made this clear by writing a burial permit which he recorded in the Berks County Recorder of Deeds office, saying "... Peter Rothermel by signing this indenture obligates himself and his heirs not to suffer or allow any other person or persons [to] bury or enter in or on the said [grave] yard if and unless by consent of both parties or their heirs of any of the said parties or their heirs, should [any] refuse or neglect to assist in repairing said Grave Yard then they shall forfeit all his or their right of burying in or on the said Grave Yard forever thereafter"

The heirs of Peter Rothermel, made certain no one would forget the Rothermel Burial Ground existed nor the family forget their responsibility to keep and care for the resting place of the ancestors. Upon Peter's death his heirs wrote specific instructions into the deed of transfer, reminding all of their right and responsibility saying "[the heirs]...do hereby reserve for themselves the sole right for burial on the graveyard ...and also for repairing and cutting weeds" and "the said graveyard is not to be removed by purchaser or subsequent owner."

Not all, and far too few, family burial grounds were documented it his way. As the decades passed, they were plowed under and forgotten. Those that remain often fall to neglect and disrepair as descendents moved away from the family homesteads. It is the mission of the Berks County Association of Graveyard Preservation, to locate and restore as many of these family burial grounds as is possible.

#### REICHARD / DUMM, RICHMOND TOWNSHIP

Clean-up involving brush burning and tree removal is in process at this location. Volunteers also recently

cleaned tombstones and filled groundhog holes.



History: 'The earliest confirmed interment, Michael Reichert, occurred in 1807. In 1822, Frances Hopp and Adam Reichert designated approximately 3 acres to the Catholic Congregation of Richmond Township indicating, "for the sole purpose of a chapel, school house, and burial ground". <sup>2</sup>Afterwards, this site became the graveyard for parishioners at St. Henry's Catholic Church until 1871. In 1872, at the direction of the Archbishop of Philadelphia, the land was sold to Jacob Koch.

"The deed specifies that the proceeds of the sale were to be for the use and benefit of St. Mary's Hamburg and to erect a good and substantial wall around the graveyard of said church...and to keep the wall forever in repair"3

#### DETURK#2, OLEY TOWNSHIP

BCAGP has just completed rebuilding the wall at the DeTurk graveyard in Oley Township.





History: The DeTurks were Huguenots who settled in the OleyValley in 1712. The DeTurk Homestead, including the ancillary house built in 1767 which was restored by the Historic Preservation Trust Of Berks County, is an example of early colonial architectural styles. <sup>4</sup>

#### KAUFFMAN, OLEY TOWNSHIP

We organized a work party Sunday March 13th in Oley at the Kauffman Graveyard. In addition to volunteers clearing this grave site of weeds, two trees needed to be removed to prevent damage to the wall and tombstones.



Authorization was granted to repair a section of the wall that is deteriorating. The wall is scheduled to be mended within the next few weeks. BCAGP is able to contribute the funding for one section of the wall to be fixed but there are other sections that need repair and contributions are needed .
